## AGENDA HEADING:

Ordering construction of the following: Urbandale Avenue Resurfacing from 34th Street to Beaver Avenue - Receiving bids, (6-4-24), and Setting date of hearing, (6-17-24). (Construction Estimate - \$300,000).

## SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the resurfacing of Urbandale Avenue from 34th Street to Beaver Avenue, utilizing pavement scarification and Hot Mix Asphalt (HMA) overlay to improve the surface condition and to extend the useful service life of the street.

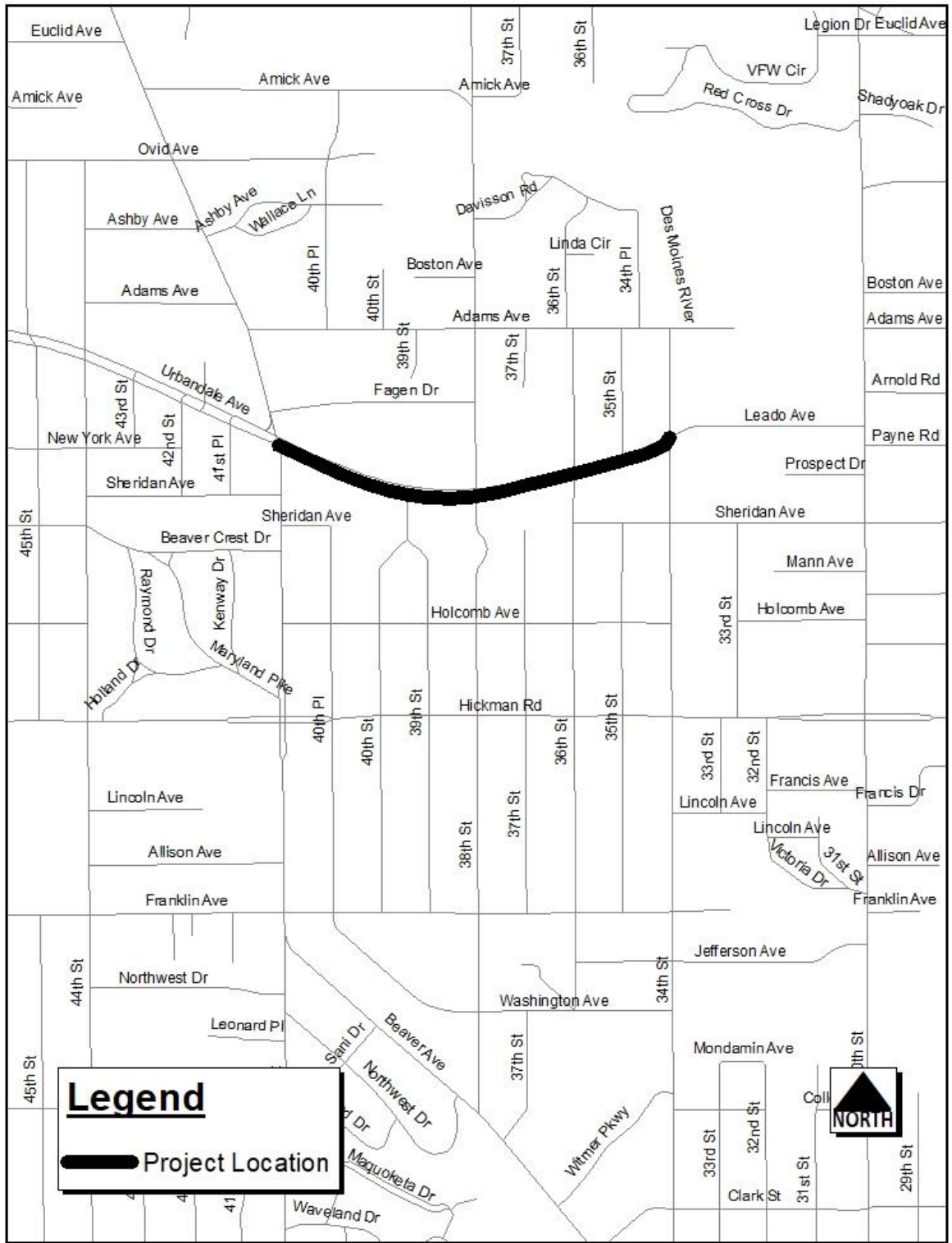
## FISCAL IMPACT:

Amount: \$300,000 City Engineer's Estimate

## ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Urbandale Avenue Resurfacing from 34th Street to Beaver Avenue, Activity ID 06-2024-014. The improvement includes scarification, furnish and place HMA pavement, pavement markings, manhole adjustments, traffic control, and other incidental items in accordance with the contract documents, including Plan File No. 663-101/113 located on Urbandale Avenue from 34th Street to Beaver Avenue.
- The estimated construction cost is \$300,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Construction of this project is anticipated to be completed by fall 2024.
