APPROVE SUBORDINATION AGREEMENTS OF EXISTING HOME INVESTMENT PARTNERSHIPS PROGRAM (HOME) MORTGAGE ON 3314 E 7th ST and 1617 22nd ST TO CENTRAL BANK CONSTRUCTION LOAN TO HOME OPPORTUNITIES MADE EASY (HOME, INC)

WHEREAS, the City has entered into an Agreement with United States Department of Housing and Urban Development ("HUD") for funding of its HOME Program pursuant to Title II of the Cranston-Gonzalez National Affordable Housing Act; and

WHEREAS, the City's HOME Program is designed to provide affordable rental and home ownership opportunities for low- and very low-income households through acquisition, rehabilitation, and new construction; and

WHEREAS, the construction of new affordable housing is consistent with the City's 2020-2024 Consolidated Plan, which was approved by City Council for submission to HUD on November 4, 2019 by Roll Call 19-1792; and

WHEREAS, on March 23, 2020 by Roll Call 20-0526, City Council approved a five-year financial commitment, totaling up to \$1,875,000 of HOME funds in the form of forgivable loans, to HOME, Inc. to construct at least 10 homeownership housing units for low-income households and provide homebuyer assistance for 22 low-income homebuyers between 2020 and 2024; and

WHEREAS, Council approved a HOME Award of \$199,000 with HOME, Inc on August 21, 2023 to construct a single-family new construction home at 1617 22nd St, secured by a forgivable HOME Mortgage in the same amount; and

WHEREAS, Council approved a HOME Award of \$199,000 with HOME, Inc on September 9, 2023 to construct a single-family new construction home at 3314 E 7th St, secured by a forgivable HOME Mortgage in the same amount; and

WHEREAS, construction loans from private lenders to complete financing of the construction projects are taken out by partners to further leverage HOME awards; and

WHEREAS, Central Bank in Ankeny reached out to Neighborhood Services staff to subordinate the HOME Mortgages to their upcoming construction mortgages on both 1617 22nd St and 3314 E 7th St. each for \$100,000, and provided the necessary request for subordination and mortgage information on April 17th, 2024, which was reviewed by staff and determined to meet the requirements to approve a subordination; and
