

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2890, 114-3423, 114-3425 and repealing 114-12727, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2890, 114-3423, 114-3425 and repealing 114-12727, relating to traffic and vehicle regulations, as follows:

Sec. 114-1272. ~~Thirty-fifth Street~~ Repealed by Ord. No. --,---.

~~Thirty-fifth Street, from Ingersoll Avenue to University Avenue, 30 miles per hour.~~

Sec. 114-2890. ~~Thirty-fifth Street--John Lynde Road to Adams Avenue.~~

Thirty-fifth Street, on the east side, from John Lynde Road to St. John's Road, no parking any time.

Thirty-fifth Street, on the east side, from Grand Avenue to University Avenue, no parking any time.

Thirty-fifth Street, on the west side, from Grand Avenue to a point ~~75~~50 feet north of ~~Iola Avenue~~Cottage Grove Avenue, no parking any time.

~~Thirty-fifth Street, on the west side, from a point 75 feet north of Iola Avenue to a point 50 feet south of Kingman Boulevard, no parking Monday through Saturday.~~

~~Thirty-fifth Street, on the west side, from a point 50 feet south of Kingman Boulevard to a point 50 feet north of Cottage Grove Avenue, no parking any time.~~

Thirty-fifth Street, on the west side, from a point 50 feet north of Cottage Grove Avenue to a point 150 feet south of University Avenue, no parking Monday through Saturday.

Thirty-fifth Street, on the west side, from a point 150 feet south of University Avenue to University Avenue, no parking any time.

Thirty-fifth Street, on the east side, from Hickman Road to Sheridan Avenue, no parking any time.

Thirty-fifth Street, on the west side, from Franklin Avenue to Hickman Road, no parking any time.

Thirty-fifth Street, on the east side, from a point 50 feet south of Hickman Road to Hickman Road, no parking any time.

Thirty-fifth Street, on the east side, from Urbandale Avenue to Adams Avenue, no parking any time.

Sec. 114-3423. Locust Street--Fifth Avenue to Sixth Avenue.

Locust Street, on the south side, from Fifth Avenue to a point 100 feet west thereof, no parking any time.

Locust Street, on the south side, from a point 100 feet west of Fifth Avenue to a point 95 feet west thereof, commercial loading zone.

~~Locust Street, on the south side, from a point 195 feet west of Fifth Avenue to Sixth Avenue, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.~~

Locust Street, on the north side, from a point 60 feet west of Fifth Avenue to a point 85 feet west thereof, no parking any time.

Sec. 114-3425. Locust Street--Seventh Street to Eighth Street.

Locust Street, on the south side, from Seventh Street to a point 110 feet west thereof, no parking any time.

~~Locust Street, on the south side, from a point 110 feet west of Seventh Street to a point 100 feet west thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.~~

Locust Street, on the south side, from a point 210 feet west of Seventh Street to Eighth Street, no parking any time.

~~Locust Street, on the north side, from Seventh Street to Eighth Street, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.~~

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
