**ORDERING CONSTRUCTION OF
2024 HMA RESURFACING PROGRAM CONTRACT 1
AND FIXING A DATE FOR RECEIVING OF BIDS ON MAY 21, 2024
AND PUBLIC HEARING ON JUNE 03, 2024
ENGINEER'S ESTIMATE IS \$1,200,000**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

2024 HMA Resurfacing Program Contract 1, Activity ID 062024002

The improvement includes scarification of existing asphalt streets, furnish and place Hot Mix Asphalt (HMA), furnish and place pavement markings, traffic control and other incidental items, all in accordance with the contract documents including Plan File No. 663-070/100, at the following locations and other locations directed by the City Engineer in Des Moines, Iowa:

- 8th Street - Boston Avenue to Ovid Avenue
- 17th Street - Crocker Street to School Street
- SW 26th Street - Thornton Avenue to Watrous Avenue
- Boston Ave - 2nd Avenue to 6th Avenue
- Des Moines Street - E 6th Street to Pennsylvania Avenue
- Kingman Boulevard - Polk Boulevard to 33rd Street
- Madison Avenue - Beaver Avenue to 50th Street

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$1,200,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on June 03, 2024, at which time this Council will consider any objections offered thereto or to the making of said improvement.
