## AGENDA HEADING:

Approval of parking license agreement and approval of amendment to parking agreement with Wells Fargo Financial, Inc.

## SYNOPSIS:

Wells Fargo Financial, Inc. (WFF) (Tom Shippee, President and CEO, 800 Walnut Street, Des Moines, IA 50310) has recently purchased an office building at 701 5<sup>th</sup> Avenue. In conjunction with this purchase, WFF desires a parking license agreement for use of spaces in the city-owned Park & Ride Garage at 7<sup>th</sup> and Center Streets.

The amendment to the January 6, 2003, parking agreement incorporates a restriction that WFF shall not sell or lease available parking spaces within its private parking garage to the general public at rates lower than the prevailing rates in City parking garages.

## FISCAL IMPACT:

Amount: \$170,856 (annual revenue)

## ADDITIONAL INFORMATION:

The parking license agreement grants Wells Fargo Financial, Inc. the use of 226 parking spaces in the 7<sup>th</sup> & Center Park and Ride Garage. The term of the agreement shall be for 10 years and commence on April 1, 2009. Wells Fargo Financial, Inc. may extend the term for two additional periods of 5 years each. The monthly rate shall be \$63 per space. After December 31, 2009, the rate shall be periodically adjusted in accordance with the prevailing market rate as determined by the City Council.

These parking spaces are currently being provided to Allied/Nationwide Insurance Company, the previous owner of the building at 701 5<sup>th</sup> Avenue, under an informal monthly parking arrangement. The license agreement with Wells Fargo Financial, Inc. will formalize this parking and maintain the occupancy and revenue streams for the 7<sup>th</sup> & Center Park and Ride facility.
