A. Code Modification to restrict parking on both sides of 12th Street from Walnut Street to Grand Avenue from 6:00 p.m. to 6:00 a.m. on Fridays, Saturdays, and Sundays.



## **ADDITIONAL INFORMATION:**

A. The Des Moines Police Department is requesting that parking be restricted on both sides of 12th Street from 6:00 p.m. to 6:00 a.m. on Fridays, Saturdays, and Sundays between Walnut Street and Grand Avenue to address issues attributed to traffic circulating or "scooping the loop" in the downtown area during these hours and days. The following code modifications will place these changes into effect.



Sec. 114-602. Parking prohibited during certain hours on certain days.

(19) No parking 6:00 p.m. to 6:00 a.m., Friday, Saturday, and Sunday.

Sec. 114-603. Stopping or standing prohibited during certain hours and days.

When signs are erected giving notice thereof, no person shall park a vehicle between the hours specified in this section on certain days at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction:

- (a) When signs are erected giving notice thereof, no person shall stop or stand a vehicle between the hours of 7:00 a.m. and 5:00 p.m. on any school day at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction.
- (b) When signs are erected giving notice thereof, no person shall stop or stand a vehicle between the hours of 6:00 a.m. and 6:00 p.m. at any of the locations designated in division 9 of article XVI of this chapter as subject to such restriction.
- (c) A person who violates any provision of this section shall pay a fine of \$15.00.

- (1) No standing or stopping 7:00 a.m. and 5:00 p.m. on any school day.
- (2) No standing or stopping 6:00 a.m. and 6:00 p.m.
- (3) No standing or stopping 6:00 p.m. until 6:00 a.m. on Friday, Saturday and Sunday.
- (4) A person who violates any provision of this section shall pay a fine of \$15.00

Sec. 114-2725. Twelfth Street—Walnut Street to Locust Street.

Twelfth Street, on the east side, from a point 30 feet north of Walnut Street to Locust Street, no parking, standing or stopping from 6:00 p.m. until 6:00 a.m. on Friday, Saturday and Sunday.

Twelfth Street, on the west side, from Walnut Street to Locust Street, no parking, standing or stopping from 6:00 p.m. until 6:00 a.m. on Friday, Saturday and Sunday.

Sec. 114-2726. Twelfth Street—Locust Street to Grand Avenue.

Twelfth Street, on the east side, from a point 50 feet north of Locust Street to a point 45 feet south of Grand Avenue, no parking, standing or stopping from 6:00 p.m. to 6:00 a.m. on Friday, Saturday and Sunday.

Twelfth Street, on the west side, from a point 30 feet north of Locust Street to a point 200 feet north thereof, no parking, standing or stopping from 6:00 p.m. to 6:00 a.m. on Friday, Saturday and Sunday.

Twelfth Street, on the west side, from a point 45 feet south of Grand Avenue 200 feet north of Locust Street to a point 34 feet south north thereof, loading zone.

Twelfth Street, on the west side, from a point 234 feet north of Locust Street to a point 22 feet north thereof, no parking, standing or stopping from 6:00 p.m. to 6:00 a.m. on Friday, Saturday and Sunday.
