SYNOPSIS —

The following traffic regulation changes have been reviewed by staff and are recommended for approval:

- A. Request to shorten existing corner clearance on the north side of Woodland Avenue west of Twenty-fourth Street.
- B. Request for *No Parking* on east side of Southeast Seventeenth Street from Park Avenue to Glenwood Drive.
- C. Request for *No Parking* on east side of East Sixth Street from East River Drive to East University Avenue.

RECOMMENDATION —

Refer to the Legal Department for preparation of ordinance revisions.

BACKGROUND —

- A. The property owner at 2406 Woodland Avenue has requested that the existing corner clearance on the north side of Woodland Avenue west of Twenty-fourth Street be shortened from 125 feet to 50 feet. This will permit parking for two additional vehicles and will still provide adequate sight distance for approaching traffic. The following modification to the Municipal Code will place this change into effect:

SEC. 27-2756. WOODLAND AVENUE—MARTIN LUTHER KING JR. PARKWAY TO TWENTY-EIGHTH STREET.

Woodland Avenue, on the north side, from a point 100 feet east of Twenty-fourth Street to a point 125 50 feet west of Twenty-fourth Street, no parking any time.

- B. Regency Management has requested that parking be restricted on one side of Southeast Seventeenth Street between East Park Avenue and Glenwood Drive to facilitate curbside mail delivery. The following modification to the Municipal Code will place this change into effect:

SEC. 27-1751. SOUTHEAST SEVENTEENTH STREET—EAST LEACH AVENUE TO EAST EMMA AVENUE.

Southeast Seventeenth Street, on the east side, from Glenwood Drive to East Park Avenue, no parking any time.

- C. In order to allow the designation of a left-turning lane northbound on East Sixth Street at the intersection of East University Avenue, it is necessary to prohibit parking on the east side of the street between East River Drive and East University Avenue. The following ordinance revision is necessary to implement this change:

SEC. 27-1632. EAST SIXTH STREET—DES MOINES STREET TO EAST UNIVERSITY AVENUE.

East Sixth Street, on the east side, from a point 775 feet north of Buchanan Street to ~~East University Avenue~~
Filmore Street, no parking 7:00 A.M. to 5:00 P.M., school days.

East Sixth Street, on the east side, from Filmore Street to East University Avenue, no parking any time.
