SYNOPSIS -

The 1998 Iowa Legislature appropriated \$945,000 from the Rebuild Iowa Infrastructure Fund to the Iowa Department of Transportation (IDOT) for the fiscal year beginning July 1, 1998, and ending June 30, 1999, for improvements at all ten Commercial Service Airports within the State.

The program provides for one-half of the funds to be allocated equally between each of the Commercial Service Airports and one-half of the funds allocated to each Commercial Service Airport based on the number of enplanements each commercial airport bears to the total enplaned passengers in the State during the previous fiscal year. The Rebuild Iowa Infrastructure Fund distribution formula will provide the Des Moines International Airport with \$317,340 for eligible projects.

There is no impact on the City's General Fund. The appropriated grant funds will be used to fund the projects listed above. Costs above the grant allocation will be from previously approved Airport Enterprise, AIP, and PFC Funds.

RECOMMENDATION -

Accept and approve the IDOT Agreement No. 03407; and the Mayor is authorized to sign said agreement on behalf of the City and the City Clerk is authorized and directed to attest to the same.

BACKGROUND -

On July 7, 1998, by Resolution No. A98-241, the Airport

Board authorized and directed the Airport Director to formulate and submit an application to IDOT for a Fiscal Year 1999 Rebuild Iowa Infrastructure Fund grant for the following six projects:

- Reconstruction of Main Terminal Restroom facilities
- Construction of new Business Center
- Construction of Skywalk Lobby
- Construction of Skywalk
- Modify Passenger Screening Security Checkpoint
- Relocation of Field Maintenance Facilities

On October 13, 1998, by Resolution No. A98-374, the Airport Board authorized the addition of a parking facility elevator in Stairtower # 1 of the new parking ramp to be included with the application for funding.

On November 13, 1998, the Aviation Director submitted the application for funding under the Rebuild Iowa Infrastructure for the seven projects listed above.

On December 15, 1998, the IDOT Commission approved the application and work plans for the seven projects.

On February 3, 1999, IDOT forwarded the proposed grant agreement.
