BACKGROUND -

On May 4, 1998, by Roll Call No. 98-1468, City Council approved the Gateway Project and directed the City Manager to prepare various actions related to project implementation.

On September 14, 1998, by Roll Call No. 98-2908, the City Council adopted specific Gateway implementation actions. Included in those recommendations was a professional service contract for streetscape improvements and a traffic engineering study for two-way traffic on East Locust Street.

A Request for Proposals (RFP), in accordance with the City's standard procedure for soliciting professional services, was developed for the East Locust Street Streetscape Improvements and traffic study, and was sent to the following firms:

- Brooks Borg Skiles
- Brian Clark and Associates
- CH2M Hill
- Conway+Schulte Architects
- Dunbar-Jones Partnership
- Earth Tech
- HLKB Architecture
- Jones and Jones Architects and Landscape Architects

- Rosales Gottemoeller & Associates, Inc.
- Snyder & Associates, Inc.

Proposals were received in response to the RFP from:

A selection committee was organized to evaluate the proposals received to rank the candidates to determine the most qualified based on experience, qualifications, expertise, development of the work plan, schedule, project assignments, cost of service, and references. The committee consisted of Rick Clark, Deputy City Manager; Don Tripp, Park & Recreation Director; Floyd Bentz, Acting City Engineer; Gary Fox, City Traffic Engineer; and Debra Smith, Associate Urban Designer. Mr. Red Brannan, Des Moines Development Corporation, was also invited to assist with the City selection committee. After reviewing the seven proposals, four firms were selected for an interview. The four firms selected for an interview were:

- Adamson & Associates, Inc.
- RDG Crose Gardner Shukert, Inc.
- Rosales Gottemoeller & Associates, Inc.
- Snyder & Associates, Inc.

After this interview and thorough evaluation, the committee placed the respondents in ranking order and is recommending the top ranking firm, Rosales Gottemoeller & Associates, Inc., as the consultant to be used for the East Locust Street Streetscape Improvements.
