	remedial education, work experience, youth conservation, and

on-the-job training, college-bound efforts and youth development activities.

The Department of Labor will award approximately 25 to 30 grants. The grants will serve youth between the ages of 14 to 21, both in school and out of school and who live in the EC community. According to the Request for Proposal (RFP) criteria, it is estimated that the grant funding levels will be up to \$5 million for an initial period of one year. Based on satisfactory progress toward achieving the goals, the grant can be extended to a third and fourth year and will be reduced to 75 percent of the initial grant amount. If the grant is extended to the fifth year, the grant amount will be reduced to 50 percent of the initial amount. The total amount of the grant that CIETC will be applying for is approximately \$4,185,000. The grant will also include three additional census tracts, two from the eastside of Des Moines and the third being Oakridge neighborhood.

The applicant must be a Local Workforce Investment Board (LWIB). The community that will receive the grant must be designated an EC. The grant also states the applicant must discuss the role of the Enterprise Zone/Enterprise Community board and various other entities such as the police department, parks department, school district, community college, state agencies, and faith-based organizations in the project.

CIETC has come to the Enterprise Community Steering Committee (ECSC) to request their support on this grant proposal to the Department of Labor. The ECSC is made up of several members of organizations that will be collaborating on the grant proposal, therefore presenting a conflict of interest for some of the members.

The ECSC recommended that the Economic Workgroup review the proposed project and a call vote was conducted to poll those members of the ECSC that were eligible to vote.

The results of the phone poll vote was to recommend to City Council to send a letter of endorsement to CIETC in support of their Youth Opportunity Grant proposal.
