On January 24, 2000, the City Council requested additional information on the apparent low bidder, Larson & Larson Construction, L.L.C, (2882 106th, Suite 220, Des Moines, Iowa 50322, Jeffrey C. Larson, President) for the Union Park Carousel Pavilion regarding qualifications and work experience.

Larson & Larson Construction, L.L.C. has submitted a detailed report showing company history, resources, financial capabilities, work in progress, project experience, etc. The report states Larson & Larson Construction, L.L.C. has an annual bonding capacity of \$15,000,000 and a single project bonding capacity of \$7,500,000. Council Members may obtain a copy of this report from the City Engineer.

Attached is a letter from Mr. Phillip Parrott of Shiffler Associates PLC (the architects for the Union Park Carousel Pavilion), stating he was delighted to see Larson & Larson Construction, L.L.C. submit the low bid as they are a "conscientious contractor with excellent organization and management skills and his work top quality."

Funds available for construction of the Union Park Carousel Pavilion from a combination of public and private funds are
