	BACKGROUND -
	1. The Traffic and Transportation Division received a request
	from a resident regarding visibility and turning difficulties due to parked vehicles on Kirkwood Avenue at the intersection of
	South Union Street. In order to provide adequate visibility for
	vehicles at this intersection, staff recommends that a 50-foot "corner clearance" no parking zone be established on the south
	side of Kirkwood Avenue west of South Union Street. The
	following revisions to the Municipal Code are necessary to

effect this change.

SEC. 27-2357. KIRKWOOD AVENUE--SOUTH UNION STREET TO SOUTHWEST ELEVENTH STREET.

<u>Kirkwood Avenue</u>, on the south side, from South Union Street to a point 50 feet west thereof, no parking any time.

2. The Traffic and Transportation Division received a request from a resident regarding visibility and turning difficulties due to parked vehicles on Wolcott Avenue at the intersection of SW 12th Street. In order to provide adequate visibility for vehicles at this intersection, staff recommends that a 65-foot "corner clearance" no parking zone be established on the south side of Wolcott Avenue east of SW 12th Street. The following revisions to the Municipal Code are necessary to effect this change.

SEC. 27-2753. WOLCOTT AVENUE--SOUTHWEST NINTH STREET TO SOUTHWEST THIRTY-SEVENTH STREET.

Wolcott Avenue, on the south side, from Southwest Twelfth Street to a point 65 feet east thereof, no parking any time.

3. At the request of the City of Des Moines Economic Development staff, the Traffic and Transportation Division has converted the 10 parking meters on the north side of East Locust Street between East 5th Street and East 6th Street to two-hour parking meters. This conversion of the time restriction is consistent with other parking meters in this area and will support retail parking by providing turnover of the parking spaces adjacent to newly-developed businesses in this area. This proposed ordinance change would convert the 10-hour parking meters on the north side of East Locust Street from East 5th Street to East 6th Street to two-hour parking meters.

The Traffic and Transportation Division has temporarily converted these parking meters under police order, subject to approval of the City Council.

SEC. 27-2957. EAST LOCUST STREET--EAST FIFTH STREET TO EAST SIXTH STREET.

East Locust Street, on the south side, from East Fifth Street to East Sixth Street, two hour meters, 8:00 A.M. to 6:00 P.M. East Locust Street, on the north side, from a point 65 feet east of East Fifth Street to East Sixth Street, ten hour meters, two hour meters, 8:00 A.M. to 6:00 P.M.
