SYNOPSIS -

The following traffic regulation changes have been reviewed by staff and are recommended for approval:

1. Corner Clearance Parking Restriction--West Side of Mar Ella Trail South of Franklin Avenue.
2. Corner Clearance Parking Restriction--West Side of East 17th Court South of Kinsey Avenue and North Side of Kinsey Avenue East of East 17th Court.

FISCAL IMPACT -

Minor costs for signing, to be paid from Traffic and Transportation Division operating budget.

RECOMMENDATION -

Receive, file and refer to Legal Department for proper legislation.

BACKGROUND -

1. The Traffic and Transportation Division received a request from a resident at 1752 Mar Ella Trail regarding the extension of the current corner clearance on Mar Ella Trail at the intersection of Franklin Avenue. The resident also submitted a petition with signatures from the immediate parties involved supporting the parking restriction. Staff concurs with the residents' request and recommends that the current 65-foot "corner clearance" no parking zone be increased to 110 feet south of Franklin Avenue on the west side of Mar Ella Trail.

The following revisions in the Municipal Code are necessary to effect this change.

SEC. 27-2435. MAR ELLA TRAIL--WASHINGTON AVENUE TO FRANKLIN AVENUE.

Mar Ella Trail, on the west side, from Franklin Avenue to a point ~~65~~ 110 feet south thereof, no parking any time.

2. The Traffic and Transportation Division received a request from Public Works regarding turning difficulties due to parked vehicles on East 17th Court at the intersection of Kinsey Avenue. In order to provide an adequate turning radius for vehicles at this intersection, staff recommends that 50-foot "corner clearance" parking restrictions be established on the west side of East 17th Court south of Kinsey Avenue and the north side of Kinsey Avenue east of East 17th Court. The following revision to the Municipal Code is necessary to effect this change.

SEC. 27-1747. EAST SEVENTEENTH COURT--WALKER STREET TO MATTERN AVENUE.

East Seventeenth Court, on the west side, from Kinsey Avenue to a point 50 feet south thereof, no parking any time.

SEC. 27-2356.5 KINSEY AVENUE--EAST SEVENTEENTH COURT TO EAST EIGHTEENTH STREET.

Kinsey Avenue, on the north side, from East Seventeenth Court to a point 50 feet east thereof, no parking any time.
