The revenue generated from the sale of the improvements on the **MISCELLANEOUS CONTRACTS** properties is used to decrease the project cost. AUCTIONED ON MARCH 25, 2000 **RECOMMENDATION -TYPE:** Approval. **RESOLUTION** ORDINANCE **BACKGROUND** -**RECEIVE/FILE** The Des Moines International Airport's Revised Master Plan provides for the acquisition of property south of the Airport **SUBMITTED BY:** between Army Post Road and relocated Army Post Road for Airport expansion. The Airport Board has previously DONALD M. TRIPP authorized the acquisition of this property on a voluntary basis. PARK AND Approximately 33 properties have been involved in this project RECREATION and 30 have been or are in the process of being acquired. When DIRECTOR the properties are vacated, the improvements on the property are usually offered by auction to the public. Once the structures are removed, the foundations are demolished. This process recycles the structures and reduces the cost of demolition. Funds received from the sale of the improvements are used to decrease the acquisition and demolition costs associated with the project.

At this time, the demolition has been completed on approximately 12 of the properties in this project. On March 25, 2000, five additional houses, several out buildings, and other material were sold at a public auction. The property sold is listed below and the diagram attached to the roll call shows the property location.
