DONALD M. TRIPP PARK AND RECREATION DIRECTOR **BACKGROUND** -

At their June 27, 2000 meeting, the Board of Water Works Trustees approved the 28E Agreement. The goal of this corroboration is as follows:

To share maintenance responsibilities between the City of Des Moines Park and Recreation Department and Des Moines Water Works; to improve the working relationship between the two entities; to provide a positive image of the Fleur Drive corridor; to work together on the design construction of recreational trail connections through Water Works Park.

The following division of duties is contained in the 28E Agreement.

# Des Moines Water Works Responsibilities:

#### Gray's Lake

- · Provide mowing and trimming of all turf areas
- · Provide weed control
- · Provide pre-mowing litter removal
- · Apply fertilizer to turf and flower beds
- · Provide pruning of all plant material with the exception of the larger tree specimens
- · Maintain newly planted materials
- · Plant and maintain entrance flowerbed
- · Provide Water Works staff to assist in planning
- · Provide security support

#### Fleur Drive

- · Provide mowing of all turf areas including the City right-of-way
- · Provide pre-mowing litter removal
- · Apply fertilizer to turf and flower beds
- · Plant and maintain flower displays
- · Provide weed control for both turf and concrete surfaces
- · Provide pruning of plant materials
- · Provide pest control for crabapple specimens

# Carney Park

- · Provide mowing and trimming of all turf areas
- · Provide pre-mowing litter removal
- · Apply fertilizer to turf areas as instructed
- · Provide weed control

## Bill Riley Trail

- · Provide trail maintenance from Ashworth Park through Water Works Park, inclusive of grading for proper drainage, mowing shoulders, and removing fallen brush and litter. This segment has been initiated.
- · Provide security support

#### Greenhouse Use

· Provide the use of Water Work's greenhouse to grow annual flowers for planting at Water Works Park, Gray's Lake and along the Fleur Drive corridor. Although City personnel will be primarily responsible for the growing of plant materials in these facilities, Water Works personnel may be asked to assist in watering

### City of Des Moines:

- · Provide all annual flowers for City's property and Water Works Park
- · Provide plant materials for Gary's Lake and Fleur Drive improvements
- · Build an asphalt trail from Ashworth Park to the Water Works Park bridge during the summer of 2000
- · Apply for grant assistance on behalf of the Water Works for the recreational trail systems passing through Water Works Park
- · Provide matching funds for recreational trail systems passing through Water Works Park
- · Provide asphalt maintenance of trail system
- · Provide turf maintenance products for properties of City parks
- · Provide all other Gray's Lake management and operation functions including emptying trash receptacles, cleaning restrooms, maintaining buildings and structures
