This meeting will be an opportunity to work with City Managers of large cities to discuss current issues of concern.

## FISCAL IMPACT -

Cost of travel is \$1,915, \$4.550 (Fogle, Shannon, and Conley), \$1.700, \$1,275, \$1,950, and \$1,250 respectively. Funding for these trips is provided for in the 2000-2001 Operating Budget under Organizational Code PWK770105, page 8-72; Organizational Code HRS980100, page 12-10; Organizational Code PWK770113, page 8-69 (Fogle, Shannon and Conley); Organizational Code ENG070166, page 8-60; Organizational Code LGL040000, page 15-8; Organizational Code HRS980100, page 12-10; and Organization Code CMO010000, page 6-8. The total expended on City travel from July 1, 2000 through December 14, 2000, is \$223,877.88; the total amount budgeted for City travel is approximately \$346,000.

# **BACKGROUND** -

On January 20, 1992, by Roll Call No. 92-214, the City Council approved a revision to the policy for travel authorization requests. Such revision requires trips that exceed three days and \$1,250 cost to be approved by the Council. The number in parentheses indicates the total number of trips previously authorized for that individual for the current budget year; R represents resident and NR represents nonresident.
