## **BACKGROUND-**

On December 30, 1996, the City's Purchasing Agent issued an Invitation to Bid and Notice to Bidders for the "Operation and Management of food and beverage concessions and gift/news concessions at the Des Moines International Airport. Bid opening was on March 27, 1997. As a result of the bidding procedure and review of proposals, on May 6, 1997, by Resolution No. A97-129, the Airport Board recommended approval of the proposed Agreement with St. Clair Corporation d/b/a Creative Croissants for food/beverage concession operations at the Des Moines International Airport to City Council.

As the proposed term of the Agreement would be ten years, it required approval by City Council. On June 2, 1997, by Roll Call No. 97-1974, the Des Moines City Council approved the Agreement with St. Clair Development Corporation d/b/a Creative Croissants. The name of the corporation was later changed to Creative Host Services, Inc., d/b/a Creative Croissants.

GladCo presently has food and beverage facilities at airports in Pittsburgh, PA; Albany, NY; Atlantic City, NJ; and Midland Bay-Saginaw, MI. In addition, GladCo will soon begin operations at Newark, NJ, and Harrisburg, PA. With the addition of these new airports, GladCo expects annualized sales of approximately \$15,000,000 per year. Reviews found that GladCo has the experience and success of operating food and beverage concessions with a high level of customer service. References indicate GladCo has been a "Good Tenant" and the City can reasonably expect to be "very pleased" with their results.

Our review of their financial condition indicates they are reasonably indebted and appear to have operated responsibly. A comprehensive credit report was also obtained from Dun and Bradstreet. The report states GladCo employs approximately 200 persons, the general payment and credit scores have been good to average and the financial stress ranking is of the lowest risk. In essence, it has been concluded that GladCo does not appear to present a significant financial risk as a concessionaire at the airport.
