DONALD M. TRIPP PARK AND	BACKGROUND -
RECREATION DIRECTOR	Over the past two years the City of Des Moines has applied for and received grant funding in the amount of \$10,000 annually from the Iowa Commission on Volunteer Services to support training and development of AmeriCorps members.
	The AmeriCorps program is comparable to an Urban Peace Corps. Members are recruited to provide service projects worth 1,700 hours over a 12-month period. In exchange, members receive development training and can earn an educational award, provided by the State of Iowa, to be placed toward future education expenses or payment toward student loan debts.
	The primary objectives for the AmeriCorps grant are:

 \cdot To recruit and coordinate volunteer efforts in bringing members of the community into the City of Des Moines' park and open space system to enhance the quality of life and leisure experiences of the residents of Des Moines.

 \cdot To develop members in identification of environmental and beautification strategies within the City of Des Moines' park and open space system to address and correct problems inherent within the system that have not/can not be addressed by City employees.

 \cdot To expand partnerships with local neighborhoods in cooperation with Des Moines Independent School District for educating and assisting with neighborhood community gardens.

 \cdot To conserve, restore, and sustain parks, recreation facilities, and services provided to the community.

Accomplishments of the 2000 AmeriCorps Service Project include:

 \cdot 10,785 service hours from members.

 \cdot Recruitment of 1,265 volunteers who provided over 18,500 hours of service.

 \cdot Served 205 youth at the Evelyn K. Davis summer program, a collaborative effort between neighborhood associations, churches, Des Moines Police Department, and Moulton Extended Learning Center.

 \cdot Recruited 38 partner groups for the Partner In Parks Program. This program has already increased to 50 this year.

 \cdot Coordinated Adult Volunteer Program at Blank Park Zoo resulting in 90 volunteers providing over 1,600 hours of service.

· Provided 140 educational outreach programs serving 4,800 people.

The estimated value of the volunteer support provided to the City through the Botanical Center operations and the AmeriCorps program is over \$695,000.
