FISCAL IMPACT -

Cost of travel is \$3,722 (Bushore and Tuttle), \$1,493, \$1,455, \$1,750, \$1,353.85, \$1,100, and \$1,342 respectively. Funding for these trips is provided for in the 2000-2001 Operating Budget under Organizational Code HRS980100, page 12-10, (Bushore and Tuttle); Organizational Code FIN280000, page 9-74; Organizational Code CMO100000, page 6-20; Organizational Code CMO100000, page 6-20; Organizational Code FIR041000, page 10-12; Organizational Code MCC010000, page 17-7; and FIN190000, page 9-64. The total expended on City travel from July 1, 2000 through May 3, 2001, is \$423,715. \$75,000 has been transferred from the Employee Development Fund and added to the \$346,000 originally budgeted for travel. In future years, we will be sure to separate training and development from travel in the budget and in travel requests to the Council.

BACKGROUND -

On January 20, 1992, by Roll Call No. 92-214, the City Council approved a revision to the policy for travel authorization requests. Such revision requires trips that exceed three days and \$1,250 cost to be approved by the Council. The number in parentheses indicates the total number of trips previously authorized for that individual for the current budget year; R represents resident and NR represents nonresident.
