	BACKGROUND -
	On April 9, 2001, the MLK Citizen Advisory Committee approved the revised plans allowing the use of standard shapes that generally conform to the shape of the enhanced poles.

On April 23, 2001, by Roll Call No. 01-1244, the City Council passed a resolution approving a requisition with Electric Products Company of Omaha, Nebraska, to supply the revised standard shape signal poles and light poles for the MLK. Parkway Paving (SW 2nd Street to SW 7th Street).

On May 15, 2001, bids were taken by the Iowa Department of Transportation (IDOT) for the construction of the MLK Parkway project from SW 7th Street to SW 16th Street.

On May 21, 2001, by Roll Call No. 01-1589, the City Council passed a resolution approving plans, specifications, form of contract document, and engineer's estimate of cost.
