CITY ENGINEER	BACKGROUND -
	1. With the approval of Shawnee Acres, the Traffic and Transportation Division recommends that parking be restricted to one side of each street throughout the subdivision. The one-side parking restriction will facilitate emergency vehicle access, snow removal, and mail delivery. It is recommended that parking be prohibited on the north side of Jerlynn Avenue. The following revision to the Municipal Code is necessary to place this restriction into effect.
	SEC. 114-3353. JERLYNN AVENUENORTH UNION STREET TO DEAD END EAST OF EAST TENTH STREET.
	Jerlynn Avenue, on the north side, from East Tenth Street to York

Street, no parking any time.

2. The Traffic and Transportation Division received a petition from the residents on Gleaves Court asking that parking be allowed within the cul-de-sac south of Ovid Avenue, with the exception of 8:00 a.m. to 4:00 p.m. on Wednesdays (garbage collection day). The petition was signed by all of the affected residents. The Traffic and Transportation Division supports this change and has installed the required signing on a trial basis. Staff recommends that these changes be made permanent. The following revisions to the Municipal Code are necessary to place these changes into effect.

SEC. 114-3236. GLEAVES COURT--EAST OVID AVENUE TO DEAD END SOUTH.

Gleaves Court, on the west side, from East Ovid Avenue to a point 110 feet south thereof and on any part of the cul-de-sac, no parking any time.

Gleaves Court, on the east side, from East Ovid Avenue to and including any part of the cul-de-sac, no parking 8:00 a.m. to 4:00 p.m., Wednesdays.

3. The Traffic and Transportation Division received a request from a resident regarding turning difficulties due to parked vehicles at the southeast corner of SW 10th Street and Boulder Avenue. In order to provide adequate visibility for vehicles at this intersection, staff recommends that 50-foot corner clearance no parking zones be established on the east side of SW 10th Street and the south side of Boulder Avenue. The following revisions to the Municipal Code are necessary to place these parking restrictions into effect.

SEC. 114-2711. SOUTHWEST TENTH STREET--VINE STREET TO COUNTY LINE ROAD.

Southwest Tenth Street, on the east side, from Boulder Avenue to a point 50 feet south thereof, no parking any time.

SEC. 114-3022. BOULDER AVENUE--DEAD END EAST OF SW NINTH SEVENTH STREET TO DEAD END WEST OF SOUTHWEST NINTH STREET SOUTHWEST TENTH STREET.

Boulder Avenue, on the south side, from Southwest Tenth Street to a point 50 feet east thereof, no parking any time.
