The Amendment to the Agreement adds two additional services to the original scope-site planning for the Masonic Temple and an assessment of the feasibility of diagonal parking around the Western Gateway Proper.

	BACKGROUND -
	Brooks Borg & Skiles, in association with Zimmer Gunsul Frasca Partnership and Dunbar/Jones Partnership, completed the Western Gateway Framework Plan in October, 2000. The Plan was approved by Council on October 26, 2000, by Roll Call No. 00-4166. Mr. Anderson was the lead for the design team on the project.

The contract for the next component of the Western Gateway Projectthe Implementation Plan, was approved by Council on July 23, 2001, by Roll Call No. 01-2339. William Anderson Architecture, LLC is the lead consultant on the project and is working in association with Zimmer Gunsul Frasca Partnership and Dunbar/Jones Partnership.

The amendment to the Agreement for Professional Services expands the Scope of Services. Following are the additional services to be provided:

- 1. Masonic Temple Site Planning.
- 2. Feasibility Assessment of diagonal parking around the Western Gateway Proper.

The product of this project phase will be a schematic plan. This plan will be used by the project designer to create the final design, develop construction documents, and estimate costs.
