The cost allocations to the participating communities are based on an estimate of the benefit each community receives, and is not based on existing capacity or flows. The City's share of the total flow treated at the WRA Facility is approximately 72 percent of the total flow.

FISCAL IMPACT -

Funding for this project is provided for on page WRA-14 of the 2000-01 Capital Improvement Program (CIP) (Index Code 396960, Account 542010, Fund EN267, Project WRA069, Organization ENG990000). The City's share is \$206,751. Other participating communities to provide \$319,149 in accordance with a 28E Agreement.

RECOMMENDATION -

Approval of the proposed Supplemental Agreement No. 1 to the Professional Services Agreement with Veenstra & Kimm, Inc.

BACKGROUND -

The existing Facility Plan for the WRA communities was completed in 1982. The Western Area Facility Plan focused on the needs of the western suburbs and was approved by the Integrated Community Area (ICA) in 1992. This update will be more comprehensive and will assess growth and wastewater collection and treatment needs throughout the metropolitan area.

The first phase of the Facility Plan Update was designed as a preliminary review and evaluation. The first phase of the plan completed an overview of analysis of the current WRA service area, and a review and evaluation of potential additional participants in the WRA system. The results of the first phase lead to a determination of the scope of work for the second and final phase of the WRA Facility Plan.
