JIM GRANT COMMUNITY DEVELOPMENT DIRECTOR bylaws. It was also decided that staff would use the annual survey to verify that neighborhoods had amended their bylaws.

On January 16, 2002, the NRB reviewed the results of the 2001 Survey and made the following recommendations regarding the neighborhoods that did not meet the Neighborhood Recognition Policy's guidelines.

- 1. Waveland Woods has not responded to the survey or addressed the Open Meeting Policy. Despite multiple efforts by NRB Member Volm and staff, no response has been received from any representative of the association. In accordance with the Neighborhood Recognition Policy, the NRB recommends the City Council no longer formally recognize the Waveland Woods Neighborhood.
- 2. Garton West has not submitted a set of meeting minutes or addressed the Open Meeting Policy because they have not met for over a year. Several representatives of the neighborhood have informed NRB Member Muldoon that no one is interested in leadership positions and the association is no longer functioning. In accordance with the Neighborhood Recognition Policy, the NRB recomends the City Council no longer formally recognize the Garton West Neighborhood.

Several Garton West Neighborhood representatives expressed to NRB Member Muldoon an interest in joining the Fairmont Park Neighborhood Association. The President of Fairmont Park Neighborhood is favorable to the idea and is going to discuss it with his membership. The NRB intents to send a letter to both Garton West and Fairmont Park expressing their support for the idea.

- 3. Chesterfield submitted an incomplete response to the survey. On January 10, 2002, the neighborhood secretary agreed to submit the additional information. The NRB recommends giving Chesterfield until the February 6, 2002 NRB meeting to submit the information.
- 4. Jordan Park has not responded to the survey. The neighborhood secretary informed NRB Member Lumley that they have not met for over a year. Several of their members have left the neighborhood, but the remaining members would like to regroup. The association would like guidance on recruiting new members. The NRB recommends giving Jordan Park until May 3, 2002 to regroup, hold a meeting and submit the survey. The NRB also intends to send a letter to Jordan Park offering their support and advice on recruiting new members.
- 5. Laurel Hill has not responded to the survey. On December 30, 2001

the neighborhood president informed NRB Member Hogate that she would send in the information. The NRB recommends giving Laurel Hill until the February 6, 2002 NRB meeting to submit the survey and a set of minutes.

- 6. New Vision submitted an incomplete response to the survey. On January 10, 2002 the neighborhood president informed staff that she would send in the additional information. Staff recommends giving New Vision until the February 6, 2002 NRB meeting to submit a set of minutes.
- 7. Waterbury submitted a complete response to the survey but has not adopted the Open Meeting Policy. On December 12, 2001 their general membership voted to place the proposed amendment on their next meeting agenda for action, as required by their bylaws. Their next meeting is March 10, 2002. The NRB recommends giving Waterbury until March 29, 2002 to adopt the policy and submit a copy of the amendment.

The NRB sent a letter informing Garton West and Waveland Woods of their recommendation on January 23, 2002. The remaining neighborhoods were sent letters on January 24, 2002.
