SEC. 114-3704. VALLEY DRIVE-FLEUR DRIVE TO PARK AVENUE.

Valley Drive, on the north side, from Fleur Drive to a point 50 feet west thereof, no parking any time.

Valley Drive, on the south side, from Fleur Drive to Park Avenue, no parking any time.

SEC. 114-3226.01. GEORGE FLAGG PARKWAY-FLEUR DRIVE TO PARK AVENUE.

George Flagg Parkway, on the north side, from Fleur Drive to a point 50 feet west thereof, no parking any time.

George Flagg Parkway, on the south side, from Fleur Drive to Park

Avenue, no parking any time.

3. The Traffic and Transportation Division received a request from a resident regarding turning difficulties due to parked vehicles on Idaho Street at the intersection of Garfield Avenue. In order to provide adequate visibility for vehicles at this intersection, staff recommends that a 50-foot corner clearance no parking zone be established on the west side of Idaho Street north of Garfield Avenue. The following revision to the Municipal Code is necessary to place this change into effect.

SEC.114-3336. IDAHO STREET-GARFIELD AVENUE TO MORTON AVENUE.

<u>Idaho Street</u>, on the west side, from Garfield Avenue to a point 50 feet north thereof, no parking any time.

4. The Traffic and Transportation Division received a request from a resident regarding turning difficulties due to parked vehicles on Seneca Avenue at the intersection of 15th Street. In order to provide adequate visibility for vehicles at this intersection, staff recommends that a 50-foot corner clearance no parking zone be established on the north side of Seneca Avenue east of 15th Street. The following revision to the Municipal Code is necessary to place this change into effect.

SEC.114-3628. SENECA AVENUE-FIRST STREET TO FORTY-NINTH STREET.

Seneca Avenue, on the north side, from <u>a point 50 feet east of</u> Fifteenth Street to a point 50 feet west thereof of Fifteenth Street, no parking any time.

5. The Traffic and Transportation Division received a request from a resident regarding turning difficulties due to parked vehicles on Arthur Avenue at the intersection of Amherst Street. In order to provide adequate visibility for vehicles at this intersection, staff recommends that a 130-foot corner clearance no parking zone be established on the south side of Arthur Avenue west of Amherst Street. The following revision to the Municipal Code is necessary to place this change into effect.

SEC.114-2993. ARTHUR AVENUE-FIRST STREET TO EAST CITY LIMITS.

Arthur Avenue, on the south side, from a point 50 feet west of

Amherst Street to a point 130 feet east of Amherst Street, no parking any time.

6. The Traffic and Transportation Division received a petition from the residents on SE 3rd between Rose and Watrous Avenues, requesting that the on-street parking on their street be reversed from the east side to the west side of the street. The petition indicated that there is not much area to park on the east side of the street with numerous driveways, and also the mailboxes are on east side so parked vehicles make it difficult to deliver mail. The petition was signed by eight of the nine affected residences. Staff reviewed this request and, based on the consensus of the neighborhood, concurs that the parking be reversed within this section of SE 3rd Street. Along with the change in parking, 50-foot "corner clearance" no parking zones should be established on SE 3rd at both Watrous and Rose Avenue intersections.

At their January 15, 2002 meeting, the Traffic Safety Committee approved staff's recommendations based on the consensus of the neighborhood.

SEC.114-2612. SOUTHEAST THIRD STREET-EAST VINE STREET TO EAST ARMY POST ROAD.

Southeast Third Street, on the west side, from East Park Avenue to East Watrous Rose Avenue, no parking any time.

Southeast Third Street, on the west side, from East Rose Avenue to a point 50 feet south thereof, no parking any time.

Southeast Third Street, on the west side, from East Watrous Avenue to a point 50 feet north thereof, no parking any time.

Southeast Third Street, on the east side, from East Rose Avenue to a point 50 feet north thereof, no parking any time.

Southeast Third Street, on the east side, from <u>East Rose Avenue</u> to East Watrous Avenue to a point 50 feet north thereof, no parking any time.
