	RECOMMENDATION -

Approve modification of the sidewalk ordinance to provide 90 days, rather than 30, for property owners to replace the defective

sidewalk and a civil citation of up to \$500 for failure to do so.

BACKGROUND -

On January 22, 2002, the Public Works Director reported in his CIP Council budget presentation a forthcoming recommendation to modify the City's sidewalk ordinance to allow property owners more time to replace defective sidewalks. Along with that recommendation would be a requirement to replace the sidewalk or be subject to a civil citation up to \$500, significantly reducing reliance on the City's sidewalk replacement/assessment program.

A review of the Public Works Department's sidewalk replacement program shows that only 40 percent of property owners take the initiative to replace their defective sidewalks through contracts between property owners and sidewalk contractors. The remainder relies on the convenience of the City hiring a contractor, replacing their sidewalk, and assessing the cost over a five-year period. Heavy reliance on the City has resulted in delays as City crews or City sidewalk contractors are heavily engaged in sidewalk replacement in NIRP areas as well.

To encourage more property owners to replace their defective sidewalk, staff is recommending the time allowed to replace the sidewalk be extended from 30 days to 90 days and that a civil citation up to \$500 be levied if property owners fail to do so. The City would be relieved of costs associated with the replacement and the time-consuming assessment process. Once the current backlog is eliminated, a smaller City-sponsored contract would be required in the CIP.

To accommodate the limited number of income-eligible property owners, the City would continue to replace their sidewalk under assessment allowing them to receive available subsidies. Upon notice of the need to replace their sidewalks, property owners would receive information on assessment subsidy guidelines and how to apply. If approved for assessment subsidy prior to the end of the 90-day period, the City would replace the defective walk and assess the cost, thereby affording the income-eligible property owners access to subsidy assistance.
