#### SYNOPSIS —

Approval of ordinance changes regarding animal licensing and animal shelter service fees.

# FISCAL IMPACT —

\$200,000 increase in Shelter revenue.

# **RECOMMENDATION** —

Approval.

# **BACKGROUND** —

The revisions contained in this ordinance are recommended to accomplish three things:

- Increase points of service for Des Moines residents. It is hoped that Des Moines veterinarians and the Animal Rescue League will allow their clients to purchase licenses at their firms. The City Clerk will maintain a list of approved firms.
- 2) License more pets. Currently, 30% of pets are licensed in the City of Des Moines.
- 3) Raise fees so that more of the cost of operating the Animal Shelter is recovered from animal owners. Current fees cover 25% of the cost of the Animal Shelter, leaving roughly \$750,000 to be absorbed by the General Fund. It is hoped that with these fee increases, <u>half</u> of the cost of the animal shelter will be recovered from animal owners.
