#### SYNOPSIS —

Receive, file, and refer to the City Manager operational recommendations of the Affordable Housing Task Force (AHTF) concerning the Des Moines Municipal Housing Agency (DMMHA).

#### FISCAL IMPACT —

#### **BACKGROUND** —

During their March 2002 budget deliberations, the Municipal Housing Governing Board (MHGB) directed the DMMHA to prepare a Disposition Application for the purpose of selling up to 394 scattered site housing units in the Public Housing Program. The MHGB further directed DMMHA to participate in an AHTF made up of area housing non-profit agencies to develop recommendations aimed at reducing the operating costs of the Public Housing Program.

# Process Followed to Derive Recommendations

The AHTF conducted nine meetings over the course of five months, establishing five workgroups focused on the following operational areas:

- Financial Sustainability of the Public Housing Program
- Rehabilitation of Housing Units in the Public Housing Program
- 5h Homeownership Program
- Admissions and Intake
- Disposition of Scattered Site Units

Meetings were facilitated by an independent, third party, professional facilitator - Barb Ettelson, through a technical assistance grant from the Annie E. Casey Foundation and the Polk County Housing Trust Fund.
