| | BACKGROUND — |
| | The Traffic and Transportation Division received a request from a resident regarding turning difficulties due to parked vehicles on Clarkson Avenue at the Dead End west of Martin Luther King, Jr. Parkway. In order to provide adequate visibility and maneuverability, staff recommends that a no parking zone be established on the south side of Clarkson Avenue west of Martin Luther King, Jr. Parkway. The following revision to the Municipal Code is necessary to place this change into effect. |

2. At the request of the Somerset Neighborhood Association, staff has reviewed the parking restrictions on SE 3rd Street between Army Post **CITY COUNCIL** Road and Bundy Avenue. Due to the curves within this section of COMMUNICATION SE 3rd Street, staff recommends that parking be prohibited on both sides of the street. The following ordinance modifications are necessary for this 03-325 JULY 14, 2003 change. PAGE TWO SEC. 114-2613. SOUTHEAST THIRD STREET—EAST ARMY POST ROAD SOUTHEAST BURNHAM STREET TO EAST BUNDY AVENUE. Southeast Third Street, on the west side, from East Army Post Road East Bundy Avenue to Southeast Burnham Street, no parking any time. Southeast Third Street, on the east side, from East Army Post Road to a point 120 feet north of East Bundy Avenue, no parking any time. 3. The Traffic and Transportation Division received a request from a resident regarding parking on the west side of East 11th Street between Des Moines Street and Lyon Street. In order to provide parking for residents, staff recommends parking be allowed on the west side of East 11th Street from Des Moines Street to Lyon Street from 6:00 p.m. to 7:00 a.m., Monday through Friday and all day on weekends. The following revision to the Municipal Code is necessary to place this change into effect. SEC. 114-2718. EAST ELEVENTH STREET-DES MOINES STREET TO ARTHUR AVENUE. East Eleventh Street, on the west side, from Des Moines Street to Lyon Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Saturday Friday.
