FISCAL IMPACT—

Cost of travel is \$1,700; \$1,427; \$7,116.90 (from State Forfeited Funds); \$1,831; \$1,425; \$1,294; and \$1,760, respectively. Funding for these trips is provided for in the 2003-2004 Operating Budget under Index Code LGL010000, page 81; Index Code FIR011000, page 57; Index Code POL982200 (Singleton/Leporte/Kamerick), page 301; Index Code FIR070400, page 65; and Index Code CMO980460, page 302.

The amount budgeted for travel in Fiscal Year (FY) 2004 is \$489,783. The amount expended for travel in FY2004 as of March 17, 2004 is \$251,683.

BACKGROUND—

On January 20, 1992, by Roll Call No. 92-214, the City Council approved a revision to the policy for travel authorization requests. Such revision requires trips that exceed three days and \$1,250 cost to be approved by the Council. The number in parenthesis indicates the total number of trips previously authorized for that individual for the current budget year; R represents resident and NR represents non-resident.
