### SUBJECT—

Professional Services Supplemental Agreement No. 2 with Snyder & Associates, Inc., for construction phase services and wetland mitigation for the Bennett Avenue and Nierob Court/26<sup>th</sup> Street Closes Creek Storm Water Improvements, not to exceed \$40,980.00.

### SYNOPSIS—

Approval of Supplemental Agreement No. 2 with Snyder & Associates, Inc., Stephen P. Rowe, President, 501 S.W. Oralabor Road, Ankeny, Iowa 50021 to perform construction phase services and wetland mitigation in connection with the Bennett Avenue and Nierob Court/26<sup>th</sup> Street Closes Creek Storm Water Improvements.

### FISCAL IMPACT—

Compensation to the Consultant is not to exceed \$40,980.00. Funds for this Agreement are provided for in Storm Water Utility Funds, Closes Creek Watershed Improvements; Fund EN304; Organization: PWK990000; Project: STE068; Account: 543030; Activity ID: 01-2003-003.

### RECOMMENDATION—

**BACKGROUND—**

The Closes Creek Watershed, on the northwest side of Des Moines, has experienced numerous flooding events over the past several years as a result of localized rainfall. This watershed was the subject of a study in 2000-2002, which identified proposed projects to alleviate the flooding problems. The watershed covers portions of four neighborhoods in Des Moines including: Beaverdale, Waveland Park, Drake, and Kirkwood Glen. A portion of the watershed also covers areas that are not in organized neighborhoods. Significant efforts were made to conduct public meetings during the conceptual design process.

Bids for construction of the subject project will be received on June 2, 2004, and a construction contract with the lowest responsive bidder will be presented for Council consideration for award on June 7, 2004.

The storm improvement project in the Nierob Ct. area includes reconstruction of a sediment basin to minimize siltation in Witmer Pond, storm sewer piping and inlets along Washington Avenue and Mar-Ella Trail, reconstruction of storm sewer piping north of Bennett Ave west of M. L. King, Jr. Parkway, and minor wetland mitigation (less than one acre) at Chichaqua Bottoms Greenbelt in northeast Polk County. Construction phase services are needed for the construction project scheduled to begin in summer 2004.

This supplemental provides for engineering review of submittals, shop drawings, and citizen and contractor coordination. The engineering Department will provide on-site inspection documentation.
