### SUBJECT—

Approval of Supplemental Agreement No. 4 to the Agreement for the I-235 Birds Run Outlet Storm Sewer with Veenstra & Kimm, Inc.

### SYNOPSIS—

Approving Supplemental Agreement No. 4 to the Agreement for the I-235 Birds Run Outlet Storm Sewer with Veenstra & Kimm, Inc., to perform construction phase services in connection with the I-235 Birds Run Outlet Storm Sewer, Phase II in an amount not to exceed \$332,673.00.

### FISCAL IMPACT—

- \$209,584.00 - Street Improvements, I-235 Storm and Sanitary Sewer Improvements, Account 543030, Fund CPO38, Organization ENG990000, Project STR197 (Loan to be paid back in 2008, 2009 and 2010);
- \$123,089.00 - Iowa Department of Transportation

### BACKGROUND—

On August 31, 2000, by Roll Call 00-3634, the City Council approved a Predesign Agreement (Agreement No. 2001-P-028) with IDOT for Interstate 235 (I-235) from the west city limits to the north city limits. The Predesign Agreement with IDOT identified three storm sewer outlet projects that the City and IDOT are jointly responsible for, including sharing of funding

responsibilities. The three projects are identified as Birds Run, Deans Lake, and Ingersoll Run Outlet storm sewers.

On September 24, 2001, by Roll Call 01-2847, the City Council approved a Professional Services Agreement with Veenstra & Kimm, Inc. for design and right-of-way acquisition services for the I-235 Birds Run Outlet Storm Sewer. On October 7, 2002, by Roll Call 02-2390, the City Council approved Amendment No. 1 to the Professional Services Agreement with Veenstra & Kimm, Inc. for design of the Birds Run Combined Sewer Improvements. On March 10, 2003 by Roll Call 03- 74, the City Council approved Supplemental Agreement No. 3 to the Professional Services Agreement with Veenstra & Kimm, Inc. to perform construction phase services for the I-235 Birds Run Outlet Storm Sewer Phase I.

This Supplemental Agreement No. 4 covers construction phase services for the Phase II storm sewer construction contract work along Park Street from 7<sup>th</sup> Street to Keo Way, and additional Phase I work associated with the Qwest Conflict Structure located at the intersection of 7<sup>th</sup> and Park Streets.
