SUBJECT—

Professional Services Supplemental Agreement No. 3, with Veenstra & Kimm, Inc., in conjunction with the Combined Sewer Overflow Flow Metering Installation.

SYNOPSIS—

This action would approve a Professional Services Supplemental Agreement No. 3, with Veenstra & Kimm, Inc., H.R. Veenstra, President, 3000 Westown Parkway, West Des Moines, IA 50266-1320, in conjunction with the Combined Sewer Overflow Flow Metering Installation, in an amount not to exceed \$5,000.00, for services to modify the Combined Sewer Overflow Long Term Control Strategy and Implementation Plan, prioritize the implementation of improvements, and develop one or more methods of quantifying the benefit from various improvement projects as requested by the Iowa Department of Natural Resources.

FISCAL IMPACT—

Compensation to the consultant is not to exceed \$5,000.00. Funds are available in Sanitary Sewer Funds, CSO Flow Meter Installation, Account 543040; Fund EN104; Organization PWK990000; Project SAE083, Activity ID 01-1999-005.

RECOMMENDATION—

Approval.

BACKGROUND—

On January 25, 1999, by Roll Call No. 99-147, the City Council approved a Professional Services Agreement with Veenstra & Kimm, Inc., H.R. Veenstra, President, 3000 Westown Parkway, West Des Moines, IA, 50266-1320, in an amount of \$86,942, for Services to complete an evaluation and develop design recommendations for fourteen combined sewer overflows.

On April 3, 2000, by Roll Call No. 00-933, City Council approved Supplemental Agreement No. 1 with Veenstra & Kimm, Inc., in an amount of \$44,200, for Design and Development Services to develop detailed plans and specifications for five combined sewer overflows.

On October 7, 2002, by Roll Call No. 02-2393, City Council approved Supplemental Agreement No. 2 with Veenstra & Kimm, Inc., in an amount of \$49,500, for Services to prepare a long term control plan and implementation strategy for the combined sewer overflow.

This Supplemental Agreement No. 3 includes the services to modify the Combined Sewer Overflow Long Term Control Strategy and Implementation Plan, prioritize the implementation of improvements, and develop one or more methods of quantifying the benefit from various improvement projects as requested by the Iowa Department of Natural Resources. The consultant shall develop an alternative implementation strategy and timeline to propose to the Iowa Department of Natural Resources based on a prioritization of improvements, develop one or more methods of quantifying the potential benefits of the prioritized improvements in the Combined Sewer Overflow Long Term Control Strategy and Implementation Plan, and provide assistance in negotiations and discussions with the Iowa Department of Natural Resources leading to the approval of Combined Sewer Overflow Long Term Control and Implementation Plan and a mutually agreeable schedule for implementation.
