SUBJECT—

Traffic Regulation Changes

SYNOPSIS—

The following traffic regulation changes have been reviewed by staff and are recommended for approval.

- A. Traffic Signal Control Revisions
- B. Prohibited/Limited Parking Revisions
- C. Passenger Loading and Unloading Zone—Center Street from 6th Avenue to 7th Street

FISCAL IMPACT—

Minor costs for signing to be paid from the Traffic and Transportation operating budget.

BACKGROUND—

A. The reconstruction of I-235 by the Iowa Department of Transportation has included several new traffic signals at ramp intersections with City streets. In addition, the Traffic and Transportation Division has reviewed the current Municipal Code regarding locations of existing traffic signals, and has identified several locations where new traffic signals have been installed but are not included in the ordinance, or other ordinance adjustments are needed. Staff recommends that the Code be modified to reflect these signalized locations. The following revisions to the Municipal Code are necessary to place these changes into effect.

C. At the request of Childtime Children's Center, 610 Center Street, Traffic and Transportation has reviewed the parking area on the north side of Center Street, between 6th Avenue and 7th Street, for the creation of a passenger loading and unloading area during the morning drop-off hours and the evening pick-up hours. Staff recommends to convert this parking metered area to a passenger loading and unloading zone, from 7:00 a.m. to 9:00 a.m. and from 4:00 p.m. to 6:00 p.m., weekdays. This area would remain metered parking from 9:00 a.m. to 4:00 p.m. Parents dropping off or picking up children at the center also have available a 20-minute grace period to park in the 7th & Center Park and Ride Garage without fee. The following ordinance changes are needed to implement this passenger loading area.
