**Bill McCarthy**, (1-R), Chief of Police, to San Francisco, California, from April 19-23, 2006, to attend the annual meeting of the Police Executive Research Forum.

**Thomas Turner, (0-R), Human Resources Director,** to Newport Beach, California, from March 25-30, 2006, to attend a National Annual Training Conference sponsored by the National Public Employer Labor Relations Association (NPELRA) entitled "Leading the Way- Yesterday, Today, and into the Future." The conference will feature training and seminars focusing on Human Resource laws impacting public sector employment.

**Scott A. Ralston, (0-NR), Civil Engineer,** to Tenaya Lodge at Yosemite, Fish Camp, California, from May 9-13, 2006, to attend conference sponsored by the ALERT Users Group. The conference will provide a forum for public agencies to meet and share the latest developments in the flood warning field. Experts in a broad range of disciplines required for effective flood warning systems will be in attendance as well as information on preparedness programs, storm forecasting tools, flood warning system design and O&M, flood data dissemination, and R&D.
