AGENDA HEADING:

Approving the Lease Agreement with Des Moines Rowing Club for use of the Overlook Terrace at Gray's Lake Park.

RECOMMENDATION:

Recommend approval of the Des Moines Rowing Club Lease Agreement for use of the Overlook Terrace at Gray's Lake Park. The Rowing Club has requested a lease for this location for the storage of their rowing equipment and for the management of their programs and services. The term of the Lease Agreement for use of the Overlook Terrace is four years and seven months with up to two five-year renewals for a total of 14 years and 7 months.

FISCAL IMPACT:

Amount: \$3,375.00 annually in revenues.

<u>Funding Source</u>: Proceeds from the lease will be deposited into the Property Maintenance Endowment Fund (SP767 PKS161625 page 350).

ADDITIONAL INFORMATION:

The Rowing Club currently has a one-year lease for the Tan Building at Gray's Lake Park. The new rowing dock at the Southwest corner of the Overlook Terrace is scheduled for completion in 2006, and the Rowing Club intends to relocate at this time. This will allow the existing Tan Building Lease to expire and the new Overlook Terrace Lease to take effect.

The Rowing Club also has a lease for the use of the Guzman Building at Birdland Marina, and they will continue their operations at this location.
