## **AGENDA HEADING:**

Approving and authorizing the execution of Iowa Department of Transportation (IDOT) Preconstruction Agreement for noise wall construction 31<sup>st</sup> Street to 28<sup>th</sup> Street, 26<sup>th</sup> Street east to 24<sup>th</sup> Street (westbound), 63<sup>rd</sup> Street east to Cummins Parkway (westbound), 50<sup>th</sup> Street east to Polk Boulevard (eastbound), Polk Boulevard east to 44<sup>th</sup> Street (eastbound), and 42<sup>nd</sup> Street east to 38<sup>th</sup> Street (west and eastbound).

#### **SYNOPSIS:**

Approval of the pre-construction agreement between the City of Des Moines and the IDOT for noise wall construction 31<sup>st</sup> Street to 28<sup>th</sup> Street, 26<sup>th</sup> Street east to 24<sup>th</sup> Street (westbound), 63<sup>rd</sup> Street east to Cummins Parkway (westbound), 50<sup>th</sup> Street east to Polk Boulevard (eastbound), Polk Boulevard east to 44<sup>th</sup> Street (eastbound), and 42<sup>nd</sup> Street east to 38<sup>th</sup> Street (west and eastbound) in association with I-235 reconstruction. Approval of this agreement will allow construction of the project that will be bid and administered by the IDOT. The noise walls are part of the outcome of the pre-design agreement between the City and the IDOT that was approved on August 31, 2000, by Roll Call 00-3634.

### **FISCAL IMPACT:**

Amount: None

Funding Source: The IDOT will pay all costs associated with this project.

## **ADDITIONAL INFORMATION:**

The City and IDOT have negotiated a pre-construction agreement, and the IDOT has completed the design of the noise wall construction 31<sup>st</sup> Street to 28<sup>th</sup> Street, 26<sup>th</sup> Street east to 24<sup>th</sup> Street (westbound), 63<sup>rd</sup> Street east to Cummins Parkway (westbound), 50<sup>th</sup> Street east to Polk Boulevard (eastbound), Polk Boulevard east to 44<sup>th</sup> Street (eastbound), and 42<sup>nd</sup> Street east to 38<sup>th</sup> Street (west and eastbound). This work includes noise walls that will vary in height and will be constructed with poured concrete footings, precast columns, and concrete wall panels.

The IDOT held meetings with each of the neighborhoods scheduled to receive a noise wall. The texture of the noise walls was determined by the residents and most of the noise walls will have "drystack" stone texture.

The pre-construction agreement for noise wall construction 31<sup>st</sup> Street to 28<sup>th</sup> Street, 26<sup>th</sup> Street east to 24<sup>th</sup> Street (westbound), 63<sup>rd</sup> Street east to Cummins Parkway (westbound), 50<sup>th</sup> Street east to Polk Boulevard (eastbound), Polk Boulevard east to 44<sup>th</sup> Street (eastbound), and 42<sup>nd</sup> Street east to 38<sup>th</sup> Street (west and eastbound) has been negotiated with IDOT to identify the responsibilities of the IDOT and the City regarding the administration, funding, and implementation of the project construction. Construction will be in the summer of 2006. IDOT must approve this document before work may begin.
