**AGENDA HEADING:**

Recommending approval of the following traffic regulation changes that are being presented for first reading.

- A. Additional on-street metered parking on SW 2<sup>nd</sup> Street between Vine Street and West Martin Luther King Jr. Parkway and on Water Street between Market Street and Elm Street.
- B. Parking Restrictions—South Side of Mulberry Street between 7<sup>th</sup> and 8<sup>th</sup> Streets.

**SYNOPSIS:**

Approval of the first reading of the Ordinance regarding the following traffic regulation changes:  
Additional on-street metered parking on SW 2<sup>nd</sup> Street between Vine Street and West Martin Luther King, Jr. Parkway and on Water Street between Market Street and Elm Street.

**FISCAL IMPACT:**

Amount: Minor costs.

**ADDITIONAL INFORMATION:**

- A. In coordination with the utility work on Water Street south of Court Avenue and the completion of related utility work on SW 2nd Street, Traffic and Transportation has reviewed the on-street parking in this area. On Water Street, because of the realignment of the east curb line, the on-street metered parking was adjusted to match the new curb line. In several areas on SW 2nd Street between Vine Street and West Martin Luther King Jr. Parkway and on Water Street between Market Street and Elm Street, new on-street metered parking spaces can be added to accommodate new and anticipated parking demand in this area.

In coordination with the construction of the City of Des Moines and Employer's Mutual Companies Parking Garages located on the south side of Mulberry Street between 7th and 8th Streets, the following recommended changes to the existing parking restrictions are requested to meet the planned curb line and planned parking meter layout in this area.

Sec. 114-2661. Seventh Street—Vine Street to Mulberry Street.

Seventh Street, on the west side, from Vine Street to a point ~~158 feet south of Mulberry~~ 100 feet north of Cherry Street, no parking any time.

Seventh Street, on the west side, from Mulberry Street to a point 70 feet south thereof, no parking any time.

Seventh Street, on the west side, from a point ~~28~~ 70 feet south of Mulberry Street to a point 100 feet north of Cherry Street ~~130 feet south thereof~~, no parking 7:00 a.m. to 9:00 a.m. and ~~4:00~~ 3:00 p.m. to 6:00 p.m.

~~Seventh Street, on the west side, from Mulberry Street to a point 28 feet south thereof, no parking any time.~~
