AGENDA HEADING:

Ordering construction of the following: Clover Hill Trunk Sanitary Sewer - Phase 2 - Receiving bids, (6-27-06), and Setting date of hearing, (7-10-06). (Construction Estimate - \$969,000).

SYNOPSIS:

Recommend the City Council proceed with construction of this improvement utilizing the method of financing referenced below. This project provides for the construction of a trunk sanitary sewer to serve a recently annexed area in northern Warren County in the vicinity of S.W. 9th Street between County Line Road and Highway 5. A trunk sewer connection fee district will provide for the collection of fees to finance the project as development of the area occurs. The City Council should set dates to receive bids and hold a public hearing as required by Iowa Code.

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Clover Hill Trunk Sanitary Sewer - Phase 2, 07-2006-007.

The improvement includes construction of approximately 1328 linear feet (1.f.) of 8" sanitary sewer, 1995 l.f. of 10" sanitary sewer, and 1154 l.f. of 15" sanitary sewer, including approximately 570 l.f. of tunneling and encasement, surface restoration, and other related items, all in accordance with the contract documents including Plan File Nos. 462-94/118; and located on the south side of Des Moines near the intersection of IA 5 Highway and SW 9th Street.

The proposed plans, specifications, and form of contract documents are available for public inspection in the City Engineer's Office.
