

AGENDA HEADING:

Approving Change Order No. 8 with Grimes Asphalt and Paving Corp. for additional work on the Combined Walnut Creek Trail project for a total not to exceed \$22,983.

SYNOPSIS:

Approval of Change Order No. 8 in an amount not to exceed \$22,983 with Grimes Asphalt and Paving Corp., (J.M. Yonker, President, 12021 N.W. 54th Avenue, Grimes, IA, 50111) for additional work on the Combined Walnut Creek Trail project for reconfiguring the parking lot at 6224 Grand Avenue to replace the portion of the parking lot removed for trail construction in accordance with the approved construction easement.

FISCAL IMPACT:

<u>Amount</u>: \$22,983

Funding Source: 2006-07 CIP, Page Park-21, Recreation Trails, PKS045, FY-2006 G.O. Bonds.

ADDITIONAL INFORMATION:

The construction of the Walnut Creek Trail will remove a portion of the existing parking lot at 6224 Grand Avenue (Pal Joey's Lounge, Joseph Yacavona, owner). Originally, Mr. Yacavona was to be paid for the loss of parking under an easement agreement. Mr. Yacavona has now requested that the City construct the parking lot revisions instead paying him to reconstruct the lot as part of the compensation for the construction easement. Mr. Yacavona's parking lot had to be redesigned and reconstructed due to the very narrow corridor available for the trail between Walnut Creek and the adjoining business. Ultimately, it is the City's responsibility to pay for this work, either as part of the construction contract. In accordance with the acquisition agreement for the permanent easement at this address, the City is responsible to replace the number of parking stalls that will be removed for construction of the trail. Since the plans originally submitted to the IDOT were based upon the former condition where Mr. Yacavona would build the replacement stalls, a change order is required to now include this work in the contract.
