#### **AGENDA HEADING:**

Approving Change Order No. 7 with Rognes Corporation for additional work on the Upper Union Park Sewer Separation – Phase 2 project for a total not to exceed \$45,000.

#### **SYNOPSIS:**

Recommend approval of Change Order No. 7 in an amount not to exceed \$45,000, subject to approval of the Des Moines Water Works and the City Engineer, with Rognes Corporation (Warren Rognes, President, 2005 South Ankeny Blvd., Suite 400, Ankeny, Iowa, 50023) for additional work to relocate a Des Moines Water Works water main on the Upper Union Park Sewer Separation – Phase 2 project.

#### **FISCAL IMPACT:**

Amount: \$45,000

<u>Funding Source</u>: 2006-07 CIP, Page Sanitary-18, Upper Union Park Sewer Separation Project, SAE086, being 100% funded by Des Moines Water Works.

#### ADDITIONAL INFORMATION:

On June 20, 2006, the Des Moines Water Works requested that the City of Des Moines remove and replace the water main on North Union Street from Tiffin Avenue to Ovid Avenue. Rognes Corporation, the City's contractor on the Upper Union Park Sewer Separation – Phase 2 project, removed the street surface in this area, and it was determined by Water Works staff that the 8" water main was only two feet below the street, and therefore subject to freezing conditions in the winter. Water Works staff requested this main be reconstructed by the City's contractor at 100% Water Works expense, not to exceed \$45,000

and subject to approval of the Des Moines Water Works. The details of the change order are being worked out with Des Moines Water Works staff. In order to expedite the work, the Des Moines Water Works may supply the materials to be installed by the City's contractor.

This water main needs to be reconstructed as soon as possible to prevent delay in the construction of this sanitary sewer and storm sewer project and prevent further delay in repaving the street resulting in inconvenience to the neighborhood.
