AGENDA HEADING:

Approval of Conveyance of 1442 9th Street to Greater Des Moines Habitat for Humanity, Inc.

SYNOPSIS:

Recommend approval to sell Des Moines Municipal Housing Agency (DMMHA) disposition property to Greater Des Moines Habitat for Humanity, Inc.

FISCAL IMPACT:

Amount: \$67,500 and a five-year restrictive covenant of affordability

Funding Source: SP350 HSG070000, pg. 225.

The proceeds from the sale will be used as follows:

- Affordable Housing Endowment Fund (75%)
- Physical Improvements to existing Manors (25%)

ADDITIONAL INFORMATION:

The Housing Services Department received approval for its application to dispose of 394 public housing units at fair market value via a public bid on August 19, 2003. According to federal regulations, sales can be negotiated with a specific buyer when there is a commensurate public benefit.

An Iowa not-for-profit entity, the Greater Des Moines Habitat for Humanity, Inc. has a long track record of providing affordable housing in the City of Des Moines while meeting the requirements of federally funded housing programs. The organization is able to meet the requirements of DMMHA's disposition plan.

The Greater Des Moines Habitat for Humanity, Inc intends to use this property for its Affordable Homeownership Program, which benefits households with incomes below 80% of HUD median income guidelines.

DMMHA has received HUD approval for this negotiated sale.
