

### **AGENDA HEADING:**

Hearing on sale of city-owned property in the vicinity of Martin Luther King Jr. Parkway and High Street to Hubbell Realty Company.

#### **SYNOPSIS:**

Hubbell Realty Company (Rick Tollakson, President and CEO, 6900 Westown Parkway, West Des Moines, IA 50266) has submitted an offer to purchase the above referenced property near the intersection of High Street and Martin Luther King Jr. Parkway for residential development.

#### **ADDITIONAL INFORMATION:**

Please see the attached Plat of Survey for identification of Lots B, C, and D.

The City previously sold Lots B and D to Knapp Properties, Inc. (Gerard D. Neugent, President, 4949 Westown Parkway, West Des Moines, IA 50266). Knapp developed Lot D for Ingersoll Family Physicians. Knapp intended to develop housing on Lot B and has a right of first refusal with the City for acquisition and residential development of Lot C. Hubbell will acquire Lot B from Knapp and Lot C from the City for the development of at least 15,000 square feet of residential development.

The City Manager must approve Hubbell's site plan and conceptual development prior to closing,

The Real Estate Division of the Engineering Department has determined the fair market value of Lot C to be \$5 per square foot. The value includes a covenant limiting the property exclusively to residential use and reservation of storm sewer easements.
