AGENDA HEADING:

Authorize payment of condemnation award for the acquisition of property located at 3000 Twana Drive for the Twana/Bel-Aire Relief Storm Sewer Project in the amount of \$8,000.

SYNOPSIS:

Approval of payment of condemnation award for a Permanent Easement for Storm Sewer and Temporary Easement for Construction in the amount of \$8,000. This action is necessary to authorize payment of the condemnation award, which allows the City to obtain legal possession of the easement area and proceed with construction of the sewer project.

ADDITIONAL INFORMATION:

Dustin K. Boyer is the property owner of property located at 3000 Twana Drive, which was identified for acquisition of a permanent easement for storm sewer and temporary easement for construction for the Twana/ Bel-Aire Relief Storm Sewer Project. The City's Real Estate Division was unable to negotiate a voluntary settlement and condemnation proceedings were subsequently instituted for the aforementioned property interests.

The Polk County Condemnation Commissioners convened on August 2, 2006, in Des Moines, Iowa and the sheriff has submitted the certification of costs and awards of said proceeding. The Real Estate Division and Legal Department recommend approval of this award so the project can advance. Pursuant to section 6B.25 of the Iowa Code, the award must be deposited with the sheriff in order for the City to proceed to enter on to the property and take possession as is necessary for the project to proceed.
