AGENDA HEADING:

Approving and authorizing the execution of Iowa Department of Transportation Agreement for Resurfacing E. 14th/S.E. 14th Street (U.S. 69) from the Des Moines River Bridge to Garfield Avenue.

SYNOPSIS:

Approval of Iowa Department of Transportation (IDOT) Agreement No. 2007-6-005 for Resurfacing E. 14th/S.E. 14th Street (U.S. 69) from the Des Moines River Bridge to Garfield Avenue. IDOT funds will be utilized to construct the minimum 3” thick hot mix asphalt resurfacing at an estimated cost of approximately \$900,000. The City will only be responsible for costs of curb replacement and adjustment of sewer manholes, estimated to be \$39,217.

FISCAL IMPACT:

Amount: \$39,217

Funding Source: Various funding sources as follows:

- 2006-07 CIP, Page Street-35, Rehabilitation and Preservation of Major Roadways, STR222, \$26,417 for curb replacement
- 2006-07 CIP, Page Storm-5, City-Wide Storm Water Utility Projects, STE057, \$8,320 for storm sewer manhole adjustment
- 2006-07 CIP, Page Sanitary-5, City-Wide Sanitary Sewers, SAE054, \$4,480 for sanitary sewer manhole adjustment

ADDITIONAL INFORMATION:

The Iowa DOT has determined that it is necessary to perform minimum 3” thick hot mix asphalt resurfacing on E. 14th/S.E. 14th Street (U.S. Primary Highway No. 69) from the Des Moines River Bridge to Garfield Avenue. Prior to placement of the minimum 3” thick overlay, milling, full depth patching, adjustment of sewer manholes, and curb replacement will occur. The City of Des Moines will only be responsible to reimburse the Iowa DOT for the costs of curb replacement and adjustment of sewer manholes, which is estimated to be \$39,217. The Iowa DOT will maintain traffic on E. 14th/S.E. 14th Street during the construction of this project. This is an Iowa DOT project; therefore, the Iowa DOT will be the contracting authority responsible for construction of the project.
