## **AGENDA HEADING:**

Approving and authorizing the execution of Iowa Department of Transportation Agreement for resurfacing Euclid Avenue (U.S. 6) from 6<sup>th</sup> Avenue to M.L. King, Jr. Parkway.

## **SYNOPSIS:**

Approval of Iowa Department of Transportation (IDOT) Agreement No. 2006-6-167 for resurfacing Euclid Avenue (U.S. 6) from 6<sup>th</sup> Avenue to M.L. King, Jr. Parkway. IDOT funds will be utilized to construct the minimum 3" thick hot mix asphalt resurfacing at an estimated cost of approximately \$800,000. The City will only be responsible for costs of curb replacement, adjustment of sewer manholes, and intake replacement, estimated to be \$60,399.

### **FISCAL IMPACT:**

Amount: \$60,399

Funding Source: Various funding sources as follows:

- 2006-07 CIP, Page Street-35, Rehabilitation and Preservation of Major Roadways, STR222, \$9,470 for curb replacement
- 2006-07 CIP, Page Storm-5, City-Wide Storm Water Utility Projects, STE057, \$25,478.50 for storm sewer manhole adjustment and intake replacement
- 2006-07 CIP, Page Sanitary-5, City-Wide Sanitary Sewers, SAE054, \$25,450.50 for sanitary sewer manhole adjustment

### **ADDITIONAL INFORMATION:**

The IDOT has determined that it is necessary to perform minimum 3" thick hot mix asphalt resurfacing on Euclid Avenue (U.S. Primary Highway No. 6) from 6<sup>th</sup> Avenue to M.L. King, Jr. Parkway. Prior to placement of the minimum 3" thick overlay, milling, full depth patching, adjustment of sewer manholes, curb replacement, and intake replacement will occur. The City of Des Moines will only be responsible to reimburse the IDOT for the costs of curb replacement, adjustment of sewer manholes, and intake replacement, which is estimated to be \$60,399. The IDOT will maintain traffic on Euclid Avenue during the construction of this project. This is an IDOT project; therefore, the IDOT will be the contracting authority responsible for construction of the project.
