### **AGENDA HEADING:**

Request for Proposals Process for a City Vehicle and Equipment Optimization Study

# **SYNOPSIS:**

A reduction in the City's Equipment Replacement Fund in FY 2004 has yet to produce a corresponding reduction in the size of the City's vehicle and equipment fleet. It is recommended that a consultant evaluate the City's existing fleet and service level in order to determine the appropriate fleet size for the City's current service levels. A process centered on a Request for Proposals is recommended for consultant identification and selection.

## **ADDITIONAL INFORMATION:**

Various departments perform vehicle and equipment acquisition, routine maintenance, mechanical repair, and re-marketing at multiple City locations: the Aviation Department maintenance facilities, the Fire Department, the Police Department, the Parks and Recreation Maintenance Shop, the Public Works Fleet Services Division, and the Wastewater Reclamation Facility.

In FY 2004, the City reduced allocations for vehicle equipment replacement by 50 percent, from \$2,360,000 to \$1,360,000. Despite the reduction, staff has been unable to significantly reduce the size of the fleet due to service requirements. Moreover, operating and maintenance expenses for the existing fleet continue to increase.

Staff recommends the identification and selection of a qualified consultant to determine vehicle and equipment optimization and make recommendations regarding maintenance guidelines and replacement funding requirements. The selected consultant will be required to provide the following:

- Evaluation of and report on vehicle and equipment utilization
- Recommendations on maintenance practices
- Recommendations on necessary staffing levels to maintain the City's Fleet
- Recommendations on appropriate amount of replacement funding
