## **SYNOPSIS:**

Recommend approval to sell Des Moines Municipal Housing Agency disposition property located at 1303 College Avenue to Polk County.

## **FISCAL IMPACT:**

Amount: \$9,750 (sale proceeds) and a five (5) year restrictive covenant of affordability.

<u>Funding Source</u>: 2006-2007 Operating, Housing Services, Maintenance, pg. 225, SP350 HSG070000. The proceeds from the sale will be used accordingly:

- Affordable Housing Endowment Fund (75%)
- Physical Improvements to existing Manors (25%)

#### ADDITIONAL INFORMATION:

On August 19, 2003, the Housing Services Department received approval for its application to dispose of 394 Public Housing units at fair market value via a public bid. According to federal regulations, sales can be negotiated with a specific buyer when there is a commensurate public benefit.

Polk County will meet the requirements of federally funded housing programs and has the ability to meet the requirements of the DMMHA's disposition plan. Polk County intends to use this property for a household below 80% of U.S Department of Housing and Urban Development (HUD) median income guidelines.

The DMMHA has received HUD approval for this negotiated sale.
