SYNOPSIS:

Approval for the vacation and sale of such property to Michele D. Kleiber for \$150 and to Darwin D. and Shirley A. Munier for \$50. This action is required by Iowa law prior to making a final determination on the proposed sale by resolution. There is no current or anticipated public need for this property.

ADDITIONAL INFORMATION:

On June 5, 2006, by Roll Call No. 06-1093, the City Council adopted a recommendation from the City Plan and Zoning Commission that an undeveloped 14-foot wide segment of Terrace Drive extending from 56th Street to a point 150 feet to the west be vacated and sold, subject to the reservation of an easement for all existing utilities.

Some of the residents along the remaining portion of Terrace Drive appeared before the City Council on June 5, 2006 in opposition to the vacation. The right-of-way has historically been used as a pedestrian walkway providing access to Hanawalt Elementary School; however, it is not a part of the City's school route sidewalk system. The City Traffic and Transportation Division has indicated that reasonable alternative routes to the school exist and it is not necessary to maintain this right-of-way for public access.

The City Council directed that the property owners along the remaining portion of Terrace Drive be given notice throughout the vacation and conveyance process. On July 14, 2006, August 1, 2006, and August 17, 2006, the Real Estate Division mailed neighboring property owners a letter giving them the date, time, and location of the required public hearing for the sale of the subject property.

The property to be conveyed consists of approximately 2,100 square feet. Michele D. Kleiber, 122 56th Street, Des Moines, Iowa, 50312-2150, has submitted an offer for \$150, and Darwin D. and Shirley A.

Munier, 5614 Terrace Drive, Des Moines, Iowa, 50312-1554, have submitted an offer for \$50, for the sale of the above referenced street right-of-way adjoining their properties, which is equal to the Fair Market Value. Michele D. Kleiber will incorporate the property into existing owned residential property for the purpose of building a garage and paving her driveway, which is currently located within the existing Terrace Drive right-of-way. Darwin D. and Shirley A. Munier will use the property to expand their residential yard.
