ADDITIONAL INFORMATION:

Rex Sparks (NR-0), Identification Technician, to Corning, New York from October 17-20, 2006 (\$1,299), to attend the International Association of Bloodstain Pattern Analysts conference, which will provide fulfillment of his annual continuing education requirement.

Scott Neely (NR-0), Senior Police Officer, to Front Royal, Virginia from September 30 – **December 8, 2006 (\$3,810),** to attend the Bureau of Alcohol, Tobacco, Firearms & Explosives (BATFE) Explosive Detection Canine Program training. All lodging costs will be reimbursed by the BATFE upon the conclusion of the training.

Marian Gelb (R-0), Park and Recreation Board Member, to Seattle, Washington from October 8-14, 2006 (\$2,305.20), to attend a National Recreation and Park Association conference, which will provide educational sessions focused on urban conservation.

Don Tripp (R-0), Park and Recreation Director, to Seattle, Washington from October 8-14, 2006 (2,305.20), to attend the National Recreation and Park Association's national conference, in which sessions will focus on downtown parks and park design along with various related topics.

Don McLaughlin (R-0), Park Development Manager, to Seattle, Washington from October 9-14, 2006 (\$1,989.45), to attend the National Recreation and Park Association's national conference, in which sessions will focus on preserving open spaces and park development and maintenance.

Vincent Valdez (NR-0), Police Sergeant, to Albuquerque, New Mexico from October 2-5, 2006 (\$1,290), to attend the Crimestoppers International Conference with the Polk County Crimestoppers and the Greater Des Moines Convention & Visitors Bureau. Valdez will represent the City of Des Moines at the conference. The Metro's Most Wanted Fugitive Apprehension Program will be presented at the conference.

The amount budgeted for travel in Fiscal Year (FY) 2007 is \$328,255. The amount expended for travel in FY 2007 as of September 19, 2006 is \$47,527.
